For our 2023 Community Forum Hourglass hosted Strong Towns founder & president Chuck Marohn for two days of events. On April 12, at the Ware Center, Chuck presented some of the most powerful stories from his book, "Strong Towns: A Bottom-Up Revolution to Rebuild American Prosperity." Later this year, in partnership with Franklin & Marshall College, Hourglass will bring together 50 randomly selected individuals that are representative of Lancaster County for a deliberative forum on housing. Deliberative forums are useful tools in the public engagement process of developing policy. Views expressed in town hall meetings and other channels of communication are often not an accurate representation of the general public. Opinion polls and surveys, while representative of the entire public, capture views that are often uninformed, particularly on issues that are complex and that require some level of technical understanding. Policy recommendations developed through deliberative forums are both representative of the public and well-informed, as the group is educated on the topic through briefing documents and access to experts throughout the event. This work is being generously funded by the Lancaster County Community Foundation, High Foundation, and Steinman Foundation.










## Fiscal Year 2022 Revenues






## **Fiscal Year 2021 Revenues**
